

GENERAL TERMS AND CONDITIONS MADRISA TRAIL KLOSTERS 2026

§ 1 Application - Validity

- (1) MADRISA TRAIL KLOSTERS (hereinafter referred to as MTK) is an event organized by the local association Runningsports.
- (2) The General Terms and Conditions are published on the Internet at www.madrisatrail.ch. They form an integral part of the contract between the organizer and the participant in the version valid at the time of registration.

§ 2 Conditions of participation – Safety measures

- (1) All healthy, experienced, and well-trained runners **who have reached the age of 10 (T11), 14 (T24), or 16 (T33 and T54)** are eligible to participate. Each participant bears full personal responsibility for his/her state of health. They must be aware of the distance and special features (night, cold, possible snow, rain, wind, altitude) of the event and prepare themselves accordingly. Anyone who has duly registered and is in possession of an official MTK race number is eligible to participate.
- (2) Organizational measures will be announced to participants by the organizer before the start of the event. The instructions of the organizer and its appropriately identified staff must be followed at all times. In the event of violations that disrupt the proper course of the event or endanger the safety of other participants, the organizer is entitled to exclude the person concerned from the event at any time and/or to disqualify them. Legally binding declarations can only be made to participants by the organizer's authorized personnel. The participant expressly declares that they accept and will strictly comply with the protective measures of the organizer and the authorities applicable during the event period!
- (3) All rules, instructions, and specifications contained in the announcement and supplementary instructions constitute a direct contractual obligation on the part of the participant. The participant must assert any claims of any kind in connection with the contract or the services provided by the organizer against runningsports within one month after the end of the event, following the contractually agreed end of the MTK.

§ 3 Registration – Participation fee – Confirmation of registration – Terms of payment – Refund – Cancellation – Insurance

- (1) Registration takes place online on the homepage. Registration is binding for participants. Once registration is complete, participants will receive confirmation of this, which confirms and thus declares the binding contract for participation in the event. Payment is due in full at the time of registration. If the participation fee is not paid on time within 4 weeks of registration, the registration expires and the starting place is released again.
- (2) The participation fees (CHF per person) for the individual distances are as follows:

- Children under the age of 16 can participate free of charge (including in T24 & T11) for late registrations on site, the general late registration fee of CHF 20 per person will be charged.
- The exact scope of services included in a starting place can be found on the homepage.
- (3) Payments can be made in different ways: PostFinance, Credit Card, Twint, Paypal, DS Coupon
- (4) The organizer will send participants a confirmation of registration after receiving the registration form and the participation fee. The organizer reserves the right to disqualify a participant at any time and/or exclude them from the event if they have provided false personal information in their registration, are subject to a ban by an international/national association, or if there is suspicion that the participant is competing after taking prohibited substances (doping).
- (5) As part of the registration process, participants will only receive their race documents upon submission of their signed liability waiver. Participants must collect their race number and sign the liability waiver in person.
- (6) The organizer may exclude the participant from the event/terminate the contract with the participant if:
- they violate the regulations and/or the rules and instructions (before or during the event).
- they persistently disrupt the event or endanger themselves or others.
- they fail to follow the instructions of the event management or staff.
- · they behave in such a way that is contrary to the contract that immediate termination of the contract is justified.

If the organizer terminates the contract with the participant, the participant is not entitled to a refund of the participation fee.





- (7) The following cancellation conditions apply:
 - For cancellations up to June 30, 2026, we will refund 50% of the entry fee.
 - After the aforementioned deadline, the entry fee will no longer be refunded. Booked merchandise items cannot be refunded.
 - Refunds will be made within 14 working days of receipt of the written cancellation.

Requests to change to a different distance must be sent in writing by email to info@planb-event.com. No money will be refunded, and the difference, including a processing fee (CHF 20), must be paid.

As the start numbers are personalized, they may only be transferred to third parties by the organizer, not by the participant.

To transfer the starting place to a third party, the participant must send us an email to info@planb-event.com to receive instructions on how to proceed. A processing fee of CHF 20 will be charged.

It is recommended that you take out private travel cancellation insurance in advance, and it is also advisable to take out insurance that covers mountain rescue.

(8) Cancellation of this registration by the participant can only be made in writing.

§ 4 Cancellation of the event – failure to start

- (1) In the event of cancellation of the event or individual sections of the route due to force majeure (e.g., bad weather, pandemics), non-participation, or discontinuation of the race for reasons for which the organizer is not responsible, the participant is not entitled to a refund/proportional refund of the participation fee or compensation for other damages such as travel or accommodation costs.
- (2) If a registered participant does not show up at the start (no-show), there is no entitlement to a refund of the participation fee.

§ 5 Disclaimer

- (1) By completing the registration form, the participant makes a binding registration for the event they have chosen and assures the organizer, without further verification, that they have the specific prior experience and knowledge mentioned in points 1 and 2 of the regulations.
- (2) Claims for damages by the participant against the organizer, regardless of the legal basis, are excluded. This does not apply if the organizer, its legal representatives, or vicarious agents have acted with intent or gross negligence, or if the organizer is strictly liable for damages for which it is responsible, such as injury to life, limb, health, or essential contractual obligations.
- (3) The participant agrees to undergo checks (in particular mandatory equipment checks) ordered by the organizer.
- (4) The participant is fully aware of and accepts the conditions of participation and the applicable regulations. He/she expressly declares that he/she has read, understood, and accepted all the rules, regulations, and conditions contained therein.
- (5) By signing, the participant declares that they are participating in the event at their own risk and that they are adequately insured against accidents (including abroad).
- (6) The organizer accepts no liability for any health risks to the participant in connection with participation in this event. At the start of the event, the participant bindingly declares that there are no health concerns regarding their participation and that their fitness level meets the requirements of such an alpine endurance competition. They are responsible for ensuring that their equipment is in perfect condition in accordance with the regulations.
- (7) The organizer accepts no liability for lost valuables, clothing, and equipment, including during luggage transport (clothing bags, drop bags, etc.).
- (8) The organizer is not liable for any reduction in performance resulting from the participant being wholly or partially prevented from participating due to legal regulations and/or official orders.
- (9) If the participant or the organizer commissions third parties, e.g., to alert emergency services, the costs incurred shall be borne by the participant, or the organizer shall have the right to collect any costs incurred from the participant.
- (10) It is strongly recommended that participants take out (international) health insurance that also covers helicopter operations and repatriation transport.





§ 6 Data collection and use

- (1) By registering, the participant declares that they agree that the data provided in the registration form may be collected for timekeeping, placement, and results and may be passed on to third parties and published on the Internet.
- (2) The personal data provided by the participant during registration will be stored and processed solely for the purposes of organizing and running the event. This applies in particular to the data required for payment processing. By registering, the participant consents to the storage of data for this purpose.
- (3) The participant agrees that photos, film recordings, and interviews made in connection with their participation in the event may be distributed and published on radio, television, in print media, books, social media (Facebook, Instagram, event website, PLAN B homepage, YouTube, etc.) without any claim to remuneration. In addition, the participant agrees to the transfer of his/her personal data for the purpose of sending photos produced by a company commissioned by the organizer. However, the participant does not hereby declare that he/she wishes to purchase such a photo.
- (4) The participant agrees to the publication of their surname, first name, year of birth, team name, start number, and results (placings and times) in all event-related print media (participant list, results list, etc.) and in all electronic media such as the Internet.
- (5) The participant may object to the transfer and publication of their personal data to the organizer in writing or by email.
- (6) By providing their email address, the participant agrees that the organizer may use it to send them information.

§ 7 Limitation period

Claims by the participant against the organizer, regardless of their legal basis, shall become time-barred one year after the contractually agreed end of the event.

Swiss law shall apply, and the place of jurisdiction for any disputes shall be CH-7250 Klosters.
